
In the name of the Most Gracious, the Dispenser of Grace: Evidence On & Unity under the One regardless of messenger or "race"*

In the name of the Most Gracious, the Dispenser of Grace: Evidence On & Unity under the One regardless of messenger or "race"*

Believing is reasoning not seeing. There are not 63 books of scripture beginning with the Hebrew Torah bestowed upon Apostle Moses during the pre-common era; followed later by the Aramaic Gospel conveyed by Apostle Jesus in the 1st century A.D.; and followed further by the Arabic Quran recited by Apostle Muhammad in the 7th century (the "Apostles"). Rather, there is one immense graph. A graph constructed of vertices and verses whose architecture contains a hierarchal system with sub-systems based upon Set Theory although such mathematics was not discovered until 1873. Comparatively, Darwin's "*Origin of Species"* (the "*Origin*"), although published about 1200 years after the Quran, did not address sets, subsets, and the corresponding organic system or molecular sub-systems of complex life. This paper demonstrates at an introductory level, that the profound unified pattern is in the transfinite prophetic parts of piety systemically linked by Set Theory not the particle in nature, evolution, or other finite subsets.

a. The Two Issues

In such circumstances, two seminal issues arise for humanity today on and unity under God in the context of the ancient tension between scripture and science which are as follows:

- i) How could the Apostles have constructed a complex mathematical system, with sub-systems in a "...step by step..." process (exceeding the length of their independent lives) to form one consistent whole message in math and meaning, if the parts to the system arose from linguistically distinct messages and the proof on same is seen through disciplines discovered by mathematicians well after the lives of these same Apostles?
- ii) How did "...step by step evolution..." or the natural selection process gradually evolve non-living matter to a complex organic system such as a human being if one of the rules to evolution is that it "...can only choose systems that are <u>already working</u>..." ("Evolution") and a pre-requisite to complex life is the "irreducibly complex", but integrated processes of the blood clotting sub-system which contains numerous parts and cannot function without all such parts such that it could not evolve by Evolution?

The answers to the two issues show that the evidence on the errors in Evolution arise from an <u>absence</u> of a system to create complexity from simplicity, but that such a system is definitively present in the three apparently distinct religions to create one compound scripture. It is extra-ordinary mathematical irony. God's scripture expressly evidences an algebraic system with multiple sub-systems which collectively work to create a complex consistent whole truth from the apparently distinct sub-truths. However, the presence of a corresponding functioning organic system is absent in Evolution which we are told created complex life. Darwin's serious systemic errors in the Origin are attributable in secular part to the fact that his publication preceded the discovery of Set Theory and molecular biology, although both are germane to

understanding any living complex being.⁸ At an elementary level, Set Theory is the study of "[a]ny group of things that belong to a defined category" and molecular biology concerns the tiny nuts and bolts (e.g. platelets which are cell fragments which seal wounds to stop bleeding) in "biological systems" (e.g. the human circulatory system).⁹ In effect, the human blood clotting sub-system is a subset of the circulating blood system (i.e. the set) which dwells nowhere, but is almost everywhere in the complex living body (i.e. the superset). Set Theory is the organizer.

To understand the errors in Evolution, we must first "see" the sets and subsets in God's graph on the linked consistent complex scriptural truth under the rubric of an express algebraic sub-system to a larger mathematical system (the "Scriptural Network"). The breakthrough on the Scriptural Network arises when one "see's" that a verse number is also a vertice which holds up a transparent linguistic structure (i.e. the verse)¹⁰ through which unseen light passes to form the image of truth. The greatest truths are in the linked images regardless of the apparently distinct "religions". We must always loose to gain, for that is the price of realized truth.

b. Consensus in the Scriptural Network

The verse numbers of the of the Scriptural Network are actually vertices (or "nodes" in graph theory)¹¹ and are linked to linguistic truths inter-connected in math <u>and</u> meaning in accordance with a definitive mathematical system. The system is described by God as the "... the standard by which to discern the true from the false ..."¹² The application of the system in part or

whole reveals objective evidence on the divine source of the ultimate truth through consistent consensus in the 63 "books". The connected consistent consensus arises regardless of the "race" of the message, the language of the message, the region in which the message arose or the time of the message. Therefore, we can "see" the fit in the math and meaning of the parts revealed by the Prophets through the identical message on the <u>origin of the human being</u> addressed at the identical node of **Genesis 4:1** in the "*Old Testament*" and **Women 4:1** in the Quran. In other words, "41" is the identical mathematical vertice for the consistent verses on human creation by God not Evolution. There is inner consistency in math and meaning at the same point on the same subject despite the apparent outer differences e.g. language, messengers, "race", "Judaism", "Islam", time, etc.

Specifically, at **Genesis 4:1** Eve explains at the <u>micro</u> level (after sexual relations with Adam) that "With the LORD's help, I have produced a man!."₁₅ More than a 1000 years later God explains, at the <u>macro</u> level, the creation of humanity through Adam and Eve at the same vertice, but in **Women 4:1** of the Quran as follows: "Be conscious of your Sustainer, who has created you out of one living entity, and out of it created its mate, and out of the two spread abroad a multitude of men and women..." 16 Both vertices are countable subsets of "41" based upon "one-to-one correspondence", 17 a concept which "...dominates all mathematics..." 18 However, there is also correspondence in meaning on a complex truth in the Scriptural Network.

Author's Note: Although there is a converse mechanism on consensus in the standard by which to meaningfully expose alteration in scripture we limit our analysis to showing an introductory proof on creation and accountability in the context of erroneous Evolution.

How is it possible that two "books" conveyed in two different languages by two different messengers, who lived more than a 1000 years apart, can address the same truth at the same vertice? I was an assertive atheist until April 15th 2008 (after I had suffered sufficiently in Rome to re-consider the truth on God and Evolution). However, I was not willing to ignore the possibility of prophetic plagiarism common in mainstream thinking on the 63 books.

Therefore, consider this next remarkable fact. In the 7th century, the residents of the Middle East still needed to learn of numerical digits (i.e. 1 through 9), positional notation (i.e. "1" in "1000" has a higher value than "9" in "999"), nomination representation (i.e. "14" = "14" not 5) and zero (i.e. "0" is a number and a real count of nothing). Such math would come from India in 773 AD by way of an Indian diplomat who visited Iraq. It is from that point that same flowed to Europe. Original scripture was revealed without verse numbers such that there were thousands of un-enumerated verses in different languages in 63 apparently separate "books". The digits "41" did not exist at the time of Genesis on Earth within the human mind and at the time of SV 4:1 in the Middle East. More importantly, we were more than a thousand years away from the pious Professor Euler's discovery of Graph Theory. from the latest scriptural point as in the 63rd book. Yet we "see" substantive links between un-enumerated vertices fitted with verses related in meaning although the examination of relationships between connected "nodes" or points is the subject of Graph Theory. Contrary to the absurdity of prophetic plagiarism, repetition at precise points in scripture is a matter of proof on and the built

truth by the One, not plagiarism by the One's messengers.²⁴ Given our mathematical maturity we can now "see" God's intention to verify universal righteousness, not tribal rites.

c. Ordinal Characteristics of "41", Time & Randomness

Fantastically, if we reverse the digits in "41" to "14" we see time change in each of Genesis 4:1 and Women 4:1. Therefore, at Genesis 1:4 we are referred back to the creation of the Universe when God takes the good out of darkness in the first universal separation as follows: "And God saw that the light was good. Then he separated the light from the darkness." ²⁵ If we now turn to the Opening 1:4 in the Quran we are referred forward (from the perspective of Women 4:1) through the title "The Lord of the Day of Judgment". The same Lord who orchestrated the first separation (to distinguish the good light) implicitly speaks to triggering the second separation through divine judgment again to distinguish the good from the remainder. ²⁶ We say implicit because the "Day of Judgment" is a defined term in the Quran (essential to understanding human purpose on Earth) ²⁷ and in the Scriptural Network (as you shall see next).

The correctness of our understanding on the past and the approaching future separation at "14" is reinforced when we "see" further fit in the accountability of the created human on the "...day of judgment..." in the Book of Malachi of the "Old Testament". In Malachi 4:1 there is explicit separation of the "...arrogant and the wicked..." who (unlike the good) are "...burned up like straw..." ²⁸ Malachi 4:1 is the future to Genesis 1:4 and the extended future of Genesis 4:1.

Author's Note: There is more than repetition and proof in the linked verses. Upon closer examination you will "see" the bond builds consistent truth rooted in mathematical and other proof.

Message at SV 11:66 "And so, when Our judgment came to pass, by Our grace We saved Salih and those who shared his faith; and [We saved them, too,] from the ignominy of [Our rejection on] that Day [of Resurrection]. Author's Note: Our primary purpose in this life is to prepare for the after-life by embracing justice defined at minimum through faith in God, righteous conduct and belief in ultimate accountability not vengeance, violence, vice or other unjust earthly pursuits.

Author's Note: If the "...wicked will be burned up like straw..." by the "Lord of the Day of Judgment" (as at SV 1:4) who remains after such separation? The answer is in the first separation at Genesis 1:4 on the distant past. God alone can show the future in the beginning as per His Prophet Isaiah's message at 46:10 - an "Old Testament" superset to Gen. 1:4, Gen. 4:1, Malachi 4:1, SV 1:4, SV 4:1.

In other words, the ordinal values²⁹ of the digits in the vertices of the Scriptural Network add meaning. There is message in the math. Therefore, if we turn to Malachi 1:4 (as in the past to Malachi 4:1) we are given an example of the wicked through the inhabitants of the region of Edom (descending through Prophet Isaac).³⁰ Focus on our One not our one genetics by "*seeing*" the remarkable link between a verse's meaning and the ordinal characteristics of its vertice.

Random network studies confirm that the multiplicity of links in meaning, math, and time between the above six verses under the set of "14" put us beyond the probability of such links arising due to mere chance events. This little proof on six verses under the rubric of "14" should not be possible, given the inadequate state of mathematics in the four dimensional reality of our universe (as in length, width, height and time) at the time of the 63 books. To link subsets on creation and accountability through Set Theory under the defined "14" requires the existence of an extra-dimensional force as in Grace joining Apostolic reason to explain the substantive source for same. Comparatively, science cannot yet verify the extra-dimensional force working as it does with the impact of physical forces upon matter measured with equipment as at CERN. Yes, scripture is ahead of science. Hence, we "see" the extra-dimensional through the substantive consensus in math, meaning and time of the six vertices in the 1st, the 63rd and Malachi under one defined algebraic letter set despite the absence of the requisite mathematics on Earth at all material times and the linguistic differences in the "books".

d. Al-jabr³⁵ in the Quran

Why did we say "...under one defined algebraic letter set.."? There are 30 distinct letter sets (or seals) in the Quran one of which is "Ta Ha" or "TH" (the "30 Lettered Sets")³⁶ bearing an ordinal value of 9 and 5 respectively in the Hebrew alphabet and a cardinal value of 9 and 5 in Arabic (under the ancient system of mathematics called "Alphabetic Numeration").³⁷ Now consider the following equation: T + H = 14. "TH" is the distinct algebraic letter set in Chapter 20 of the Quran (set apart from the linguistic portion of the first verse in which it appears) and the Alphabetic Numeration or "AN Value" of each such letter in the set and the sum of their combined values was first published by the late Dr. Khalifa in or about 1974 in the United States.³⁸ "TH" is the algebraic definition by summation to the numerical set of "14" (which subsumes "41" as a subset based upon one-to-one correspondence).

"TH" is also the definitive evidence of the Divine extra-dimensional through the emphasized "14" and its subsets in the Scriptural Network. The truth is reinforced by the fact that Algebra (as in use of variables such as T + H as ordinary numbers in arithmetic operations)³⁹ also did not exist on earth in the 7th century.⁴⁰ Yet if we were to subtract "TH" from the Quranic vertice at which it appears (i.e. SV 20:1 once such vertice is treated as a whole integer as in "201"₄₁ we arrive at a solution that corresponds to the total number of chapters in

the physical reality of the current Torah (which contains Genesis 4:1). The equation is as follows: **201 - TH = 187**. The outer letter set and the inner number within same is the straight way to the profound pattern of the unified Truth.

The vertice (i.e. SV 20:1) takes us to the eleventh letter subset in the Quran (i.e. TH) which takes us to the equation (i.e. 201 - TH) which takes us to the solution by subset (i.e. 187) which reinforces the earlier independent links between the Torah and the Quran under "TH" which is further reinforced by the Malachi 4:1. Indeed, the Scriptural Network is not a mere graph, but a vast network with a blue print which is reassuringly similar to "real networks" in nature 42 which similarity speaks to the identical authorship of both. However, that is the basis of advance proofs on the construction of the Universe rooted in the physics of the "Big Bang", the subsequent 342 Solar Budget and the math and meaning of Quranic Algebra on same through the 7th Seal (a prestigious member of the standard referenced in SV 3:4). We raise the issue to alert the reader on the substantiation of the God proofs in the Quran before its vertices bond with the earlier revelations to collectively reveal the one Scriptural Network consistent with SV 3:3 (the quotient to "ALR" in the 7th Seal addressed in §(e) below) confirming the following: "Step by step has He bestowed upon thee from on high this divine writ, setting forth the truth which confirms whatever there still remains [of earlier revelations]: for it is He who has bestowed from on high the Torah and the Gospel."

The scientific proofs from God are not only in each vertice and its adjacent verse under the definitive 7th Seal, but also in the cumulative linked whole of the same vertices and verses under the Scriptural Network. Such proof on God and the divine source of God's networked messages (regardless of the "race" or language of the messenger) is not otherwise accessible. In other words, to "see" the largest of God's verified truths one must let go of the largest of unsubstantiated human traditions which stand opposed to such truths. By example, one cannot

sincerely argue that certain Apostles are great or the greatest because of the quality or length of a certain book(s) or their apparent "race" because all verified truth ultimately comes from the extra-dimensional not men or women. To raise rank is to deny the force of truth from the true source - an ultimate truth. In other words, prophetic ranking is unreasonable thinking. Yet it defines institutionalized "religion" today. The Apostles were members of the same superset with the same Supreme conveying parts of the same linked truth at different times to different people.

Nor is God an intellectual elitist for reason itself is not limited to Set Theory or science. Therefore, forget not the human with the vision, but without the proof on same other than his or her sincere conviction. They are not disordered, but subject to the dream with clarity in conclusion without the step by step, but with the seed, shoot and stem in one.⁴⁷ Recall the admission of the exemplary mathematician who discovered Set Theory, the hierarchy of

infinities, the transfinite and the Absolute Infinite?⁴⁸ It was Georg Cantor who declared: "*I entertain no doubt as to the truth of transfinites, which I recognized with God's help ..."* Cantor's work is essential to understanding the transfinite Scriptural Network which

5-1909. A sectarian truth, as on the "*racial*" distinction between prophets and people, is a comparative fleeting truth to God's resurrected lasting unified truth. We see same (in part) through "**TH**" in the <u>increasingly ordered Scriptural Network which like the pure milk of cattle sits surrounded by the entropic waste and the blood of the finite. The Bohlen is an entropic mess after 105 years, but the truth in the 63 "books" are increasing in order to form the one consistent anti-entropic Scriptural Network after a millennia. Such is the miraculous force of the extra-dimensional source who teaches veracity to improve our outer and inner reality.</u>

We left "*Christianity*" for the end because it contains a linked superset to "14". e. The 7th Seal & Revelation

The 62nd book is called "Revelation". The answer to our question in §(d) above is at Rev. 16:14 which provides as follows: "They are demonic spirits who work miracles and go out to all the rulers of the world to gather them for battle against the Lord on that great judgment day of God the Almighty." In "1614" we are referred to preparations for a battle against the "Lord of the Day of Judgment". A battle "...[o]n that day the arrogant and the wicked will be burned up like straw..." and hence the warning that "The LORD of Heaven's Armies says, "The day of judgment is coming..." It is remarkable, but not difficult to "see" the link in meaning and math between the seven (7) examined verses under the rubric of "TH" on the creation of people and the accountability of the created to their Creator on earth and on the Day of Judgment.

However, in Revelation 16:14 we have "16" to address beyond the "14". How does "16" relate to "TH" or fit with "TH" in math and meaning all six preceding linked verses? We will answer same with two proofs based upon the <u>ordinal properties of 16</u> in Revelation 16:14 in relation to "TH" and the <u>cardinal properties of Revelation 16:14</u> in the context of "ALMS" (another letter set from the Quran). For the first proof on "TH", we move from the cardinal value of "TH" or "14" to its ordinal characteristics as in the seventh letter set of the 7th Seal. The 7th Seal is massive, but it is only one of six extra-dimensional forces which work (once released) to break the apparent distinction between the 63 "books" and reveal the linked Scriptural Network. The seventh algebraic letter set of the 7th Seal is "**TH**" (highlighted in blue above). We do so in the context of <u>all six</u> examined verses from Genesis, Malachi, Opening, and Women on creation and accountability linked as subsets under Revelation 16:14 through "TH". It gets better - it always does if you sincerely persevere for the truth without agendas.

Genesis 4:1 links to Women 4:1 on creation and the reverse of their digits (in math and meaning) links on accountability. All is then revealed as subsets to the defined express emphasized algebraic letter set "TH" despite the differences in time, language and messenger and in the absence of the mathematical ingredients on earth for same at all material times. Such is God's brand and it is only possible if a Supreme Set is managing the process who knows the end in the beginning (recall Isaiah 46:10 on same). God then reinforced the linked truth through a further truth in the superset at Revelation 16:14 under the twin connected letter sets of "ALMS" and "TH" through the Sum of Six with consistent math and meaning. All of it was collected, linked and further branded by God as subsets to the enduring extra-dimensional anti-entropic pattern in the 7th Seal superset to leave no doubt on the intended truth and effect of ALR / 7 on the now partially revealed Scriptural Network.

Through the Sum of Six, we can also appreciate the minimum components of true religion as in faith in our One Creator, the practice of virtue (as in respectful unity in belief under One God with one non-institutionalized faith) and the accountability of the all by the same One for our earthly practices. In the words of Professor Einstein, "...science without religion is lame" and we say "religion" without math is unjust. Let us now return to that lame, all too lame theory of Evolution, originating from a man who knew neither of sets, molecular subsets or unseen systems in both.

A complex subset (such as the "...three mutually reinforcing processes..." of the human blood clotting subsystem to the circulatory system) cannot be produced by "...natural selection..." to trigger further gradual inter-species evolution given that one of the rules of such invented theory is that it "...can only choose systems that are already working..." It is akin to submitting that the three mutually reinforcing distinct sets of **ALMS**, **ALR** and **TH** sprang forth

wrong to people, but it is people who wrong themselves because it is easier for the man or woman to destroy the justice within them instead of growing same by opposing the injustice around them. The proofs effacing violence are significant in the Scriptural Network but people follow unjust human inventions.

Now consider SV 3:4 in the context of the 7th Seal: "aforetime, as a guidance unto mankind, and it is He who has bestowed [upon man] the standard by which to discern the true from the false. Behold, as for those who are bent on denying God's messages - grievous suffering awaits them: for God is almighty, an avenger of evil." Now consider in respect of the standard, the math and meaning of the following equation in the context of the 63rd Book given the on-going sectarian conflicts between "Judaism", "Christianity" and "Islam" without any understanding of the Scriptural Network: 835 + 89 + 28 + 92 = 1044.

We make the challenge in part to show the ironic commonalty between institutionalized religion and science. The origin of same is in the joint embrace of sectarianism and reductionism, respectively. True religion improves one with truth rooted in proof; it does not exclude with invented privities. There are not three, but One God, with three or more names, conveying one message through one set of messengers arising from systemically linked consistent pre-existing parts as in the Sum of Six to create the one Scriptural Network. Religion is defined by the "who" not the "how" of worship for there is only One who appointed different means of worship at

different times.⁷² The Sabbath and the Saum (as in the "*Muslim*" fast) were made to meet human needs, but the human was made for neither. The human was created to exemplify justice through trial, self-examination and conduct bearing witness to ultimate truth as in scriptural cooperation, not genetic competition. The closest to God are the just not the "*Jewish*" or the "*Gentile*".⁷³

In science too, despite the diffuse presence of networked complexity, we "see" submission to the assumption that the whole is understood by the part (called reductionism) ⁷⁴ through the sub-atomic misnomer: the "*God particle*". ⁷⁵ The sign of the God particle on the creation of matter is partly in the meta-physical 9th or 5th letter of the Hebrew alphabet "*Teth*" or "*Hey*" ⁷⁶ or their Arabic equivalent with identical cardinal values to reveal bonded compound truth, but it is not in the finite speck of the "*quark*" or the Higgs-Bosson. ⁷⁷ Yes, there is insight in the study of the sub-atomic, but there is more error if done with reductionism as with Darwinian Evolution. Surely, had the writer <u>unjustly limited</u> the breath of "**TH**" or "**ALMS**" to prove the truth of the Quran alone, he would have mislead on Truth with <u>dire consequences</u> to himself. Like the 63 books, we appear separate, but are from the One to justly cooperate as one in the name of the One. Recall Aristotle's "*central assertion*" on the main "...*relationship between the finite and the infinite: 'The whole is greater than the part.*" Hence, our evidence on "...*the Dispenser of Grace*" who constructed step by step "...*regardless of messenger or race*".
